

NIFA FEDERAL ASSISTANCE MATCHING REQUIREMENTS FOR COMPETITIVE GRANT PROGRAMS

APPLICABILITY: Pursuant to section 7614 of Pub. L. 115-334, the matching requirement in NARETPA § 1492 shall no longer apply to competitive grants awarded on or after December 21, 2018. A matching funds requirement under a “covered law” (as defined in NARETPA § 1492(d)) that was in effect on the day before the date of enactment of Pub. L. 115-334 (December 20, 2018) shall continue to apply to a grant awarded between October 1, 2014 and December 20, 2018.

Certain entities were exempt from the NARETPA § 1492 matching requirement, and NIFA was also permitted to waive the NARETPA § 1492 matching requirement under certain, limited circumstances. For programs that were in existence prior to October 1, 2014, with the removal of the NARETPA § 1492 matching requirement, they revert to earlier legislative matching requirements, as applicable and described below. Some programs will have no matching requirement, while others may have a 100% match requirement for all grantees, since previously exempted entities are no longer exempt, that cannot be waived by NIFA. For programs first-authorized or first-funded after October 1, 2014, legislative matching requirements are described below.

The matching requirements identified here are summaries only; reference should be made to the underlying statute, implementing regulations, and RFA for a complete description of the matching requirement.
